OSHA Standard 1910.1200, (29 CFR, Part 1910, Subpart z, Section (1910.)1200) Auszüge

1910.1200(b)(6)(v)

Articles (as that term is defined in paragraph (c) of this section);

1910.1200(c)

"Article" means a manufactured item other than a fluid or particle: (i) which is formed to a specific shape or design during manufacture; (ii) which has end use function(s) dependent in whole or in part upon its shape or design during end use; and (iii) which under normal conditions of use does not release more than very small quantities, e.g., minute or trace amounts of a hazardous chemical (as determined under paragraph (d) of this section), and does not pose a physical hazard or health risk to employees.

1910.1200(b)(6)(ix)

Any <u>consumer product</u> or hazardous substance, as those terms are defined in the Consumer Product Safety Act (15 U.S.C. 2051 et seq.) and Federal Hazardous Substances Act (15 U.S.C. 1261 et seq.) respectively, where the employer can show that it is used in the workplace for the purpose intended by the chemical manufacturer or importer of the product, and the use results in a duration and frequency of exposure which is not greater than the range of exposures that could reasonably be experienced by consumers when used for the purpose intended;

U.S.C. <u>TITLE 15</u> > <u>CHAPTER 47</u> > § 2052

§ 2052. Definitions

- (a) For purposes of this chapter:
- The term "consumer product" means any article, or component part thereof, produced or distributed
- (i) for sale to a consumer for use in or around a permanent or temporary household or residence, a school, in recreation, or otherwise, or
- (ii) for the personal use, consumption or enjoyment of a consumer in or around a permanent or temporary household or residence, a school, in recreation, or otherwise; but such term does not include—
- (A) any article which is not customarily produced or distributed for sale to, or use or consumption by, or enjoyment of, a consumer,
